ATTESTATIONS FOR TESTING LAB APPLICANTS

Instructions: Los Angeles Municipal Code (LAMC) section 104.09 and the Rules and Regulations for Cannabis Procedures require applicants applying to the Department of Cannabis Regulation (DCR) for Temporary Approval to conduct testing commercial cannabis activity to attest to certain eligibility qualifications. At a later date, and/or on the request of DCR, Applicants will be required to evidence compliance with these criteria.

By signing this form, you are certifying under penalty of perjury that the information you supply is accurate to the best of your knowledge. Submission of false or misleading information may result in denial of your application.

Pursuant to LAMC section 104.09 and the Rules and Regulations for Cannabis Procedures, and under penalty of perjury, I, _____ (Applicant) attest that the following is true and accurate:

Applicant understands that failure to meet any of these requirements may result in denial of a license or Temporary Approval. **If Applicant receives Temporary Approval, but is denied an ISO/IEC 17025 accreditation, Temporary Approval shall be immediately revoked and Applicant shall immediately cease all Testing Commercial Cannabis Activity.** Applicant will be required to pass an inspection prior to full licensure. At a later date, and/or on DCR's request, Applicant will provide proof of ISO/IEC 17025 accreditation or proof that Applicant is in the process of applying or is preparing to apply, as well as laboratory-employee qualifications as required by the State of California.
