**PUBLIC COMMENT:**

The Commission shall provide an opportunity for the public to address non-agenda items or general items of interest to the public that are within the subject matter jurisdiction of the Commission. This requirement is in addition to any other public hearing required or imposed by law. A person wishing to speak during a meeting must complete and submit a speaker's request form to the Commission Executive Assistant prior to the commencement of the public comment period. A person wishing to speak on a non-agenda item or multiple agenda items must do so during the General Public Comment period or the Multiple Agenda Item Comment period respectively. A person wishing to speak only on one agenda item may do so during the Single or Multiple Agenda Item comment period or when the Commission takes up the item.

An individual shall be limited to one (1) minute of general public comment per meeting. In addition, an individual shall be limited to one (1) minute of public comment per agenda item, up to two (2) minutes per meeting. In total, an individual shall be limited to three (3) minutes of public comment per meeting.

Sign language, interpreters, assistive listening devices, or other auxiliary aids and/or other services may be provided upon request.
