WHAT IS THE LAW?

Licensed RETAILERS may not:

- Sell cannabis without BOTH a state license and local authorization.
- Sell alcohol and tobacco products.
- Allow alcohol or cannabis consumption on the premises.

CONSUMERS should not:

- Use, eat, smoke, or vape cannabis in public places or places where cannabis consumption is illegal.
- Use within 1,000 feet of a school, day care center, or youth center while children are present.
- Transport cannabis across state lines, even if traveling to another state where cannabis is legal.

Licensed RETAILERS ARE REQUIRED TO:

- Prominently display both a state license AND local authorization.
- Ensure they sell adult-use cannabis only to persons 21 years old or older.
- Sell medicinal cannabis only to persons 18 years old or older with a CURRENT physicians recommendation -OR- a valid L.A. county-issued medical marijuana ID Card.
- Test, package and label all cannabis and cannabis products in accordance with City and State requirements.

CONSUMERS are allowed to:

- Possess and use on private property only with with property owner's permission.
- Buy and possess up to one ounce of cannabis and up to eight grams of concentrated cannabis if 21 years old or older.
- Purchase at retail businesses licensed by the State of California AND the City of Los Angeles.
