### Background



- The Annual Licensing process is a multistep procedure that can take up to 120 days, and includes many concurrent deadlines for both DCR and applicants.
- Because of deadlines at the State level, the City must begin its Annual Licensing process immediately to avoid any interruption in operations to licensees with upcoming State license expiration dates.

### Background



- DCR is prioritizing review of Annual Applications based on following criteria:
  - upcoming State license expiration dates;
  - non-retail Social Equity businesses who do not have State provisional license;
  - Social Equity retail businesses; and, all other businesses.

### Upcoming Deadlines



- On January 29, 2024, DCR issued the first Notices of Complete Application to 16 applicants for Storefront Retail and Microbusinesses with on-site sales (Types 10 and 12). This began the Annual License application process for these applicants.
- The Annual Licensing process for non-retail is simpler. DCR will begin reviewing those applications on a rolling basis beginning in February 2024.


